## A. Capital Raising Needs For NCG

- With a previous committee defunct, we need a new committee
- Now net 30, we need to go to net 21 to be a member. This paydown is a large amount of cost
- This money is a guarantee for that, \$40k
- UNFI is taking this to Risk Committee in 2 days
- In discussions about details on both sides of this goal
- Ultimately, we'll need cash either very shortly or within 6 months, depending
- Possible payments or loans by members and/or encouraging new members with a drive
- Moving forward with forming Capital Campaign Committee a good idea regardless
- This would all be a June expense
- First payment could be around \$16k, following months being around \$4.5k
- Will organizing a call with interested board members tomorrow

- Door service limited but possibly extending

- New avenues of competition are developing
- Online ordering will continue
- While sales numbers look somewhat negative, we are covering needs through multiple angles
- With new level in NCG, the store's value will grow and offerings will benefit shoppers
- Our long established focus on local food chains provides resilience
- The anatomy of basket size and frequency is in flux

### B. GM Monitoring

Policy B1 1st Quarter 2020 Financial Condition

- Magical time
- Compliance with some parts of this policy
- Growth of 14.9% largely due to closing of Earthfare
- Reorganization in February poised Daily to be ready for massive growth
- Membership is growing
- March saw massive growth with panic-buying and local shopping due to pandemic
- Net income is healthy
- Profit-sharing with employees was initiated in this quarter
- Expenses were in line with budget
- Kept labor in proper ratio
- Liquidity ratio is sub required but growing
- Debt to Equity ratio is not yet compliant; long-term goal
- Up to date with payments barring one Columinate payment missed in an email to bookkeeper, will print and mail these invoices in future
